International Women's Day 2012 (By Farha Najah)

SAWCC is a part of the March 8th Coordination and Action Committee -Women of Diverse Diverse Origins. The committee organised a forum on March 4th entitled, "Women Resist Canadian Mining Exploitation" so as to discuss women's crucial role in resisting a surge of mining and development aggression taking place in Canada and around the world, led by Canadian corporations. The event was held in Côte des Neiges. About 180 people participated throughout the day to listen to speeches, watch short films, participate in discussion groups, and watch cultural performances.

What you need to know about BILL C-31 (By Swathi Sekhar)

In February 2012 the Conservative government introduced **Bill C-31** to reform existing immigration and refugee laws. It is very important to stay informed and be aware of these changes. Some of the main provisions include:

- Giving the Minister sweeping powers to designate "safe countries" from which refugee claims will be fast-tracked without the option to appeal, and unlikely to succeed.
- If a refugee's country of origin is deemed to be "safe", the government has the authority to revoke the refugee status of these individuals. These refugees will have

- their permanent residence status revoked, and subsequently be removed from Canada.
- Authorizing mandatory, unreviewable detention for a minimum of one year of refugee claimants who are deemed to have arrived "irregularly". This may also include the detention of children.
- If claimants are deemed to have arrived "irregularly" Bill C-31 further prohibits these claimants from applying for permanent residence or sponsoring family members for 5 years if they are eventually successful in their refugee claims.

 The new bill seeks to streamline procedures even further, to allow quicker removals of people whose claims have been rejected.

Individuals and organizations such as SAWCC will most certainly feel the impact of these changes in the months and years to come. To find out how these changes might affect you or your loved ones, please talk to a community worker at SAWCC.

Remembering Madeleine Parent...

Madeleine Parent, a long time supporter, active member of SAWCC community, recently passed away in Montreal on March 12th, 2012 at the age of 93.

Née à Montréal en 1918, elle a mené une vie extrêmement active, au Québec et en Ontario, en tant que militante syndicale, féministe, pacifiste et humaniste.

Madeleine était une de ces personnes comme on en rencontre peu dans une vie: une femme impressionnantes qui par son action a changé le cours de notre histoire! Elle a lutté pour le droit à l'avortement, pour l'équité salariale et pour la défense des droits des femmes

immigrantes and des femmes autochtones. Elle a tissé des liens d'engagement et d'amitié auprès de nombreux organismes communautaires.



10th ANNIVERSARY OF THE GUJARAT GENOCIDE (courtesy of Dolores Chew)

On 27 February 2002, a train carrying kar sevaks (community volunteers, now often used for 'Hindu' religious volunteers) in the western Indian state of Gujarat (Gandhi's birthplace) caught fire and burned. Fifty-seven people died. There are contradictory versions of how the fire started - from within the train or set from outside. Yet the following day and for two weeks after, mobs armed with weapons, gasoline and gas cylinders, roamed the streets of Gujarat killing and murdering Muslims very brutally and in cold blood. Women and girls were particularly targeted - raped, gang-raped and burned alive. Pregnant women had foetuses ripped from their wombs. And the world has not heard much about this. The genocide is the result of Hindu nationalist mobilization in the service of making India 'Hindutva' or a Hindu nation. identification of 'Muslims' 'terrorism' in India and many parts of the world, has made the struggle of justice more challenging.

The ostensible cause of the massacre was that the train had been torched by Muslims. But how did the killings happen so quickly and in such an organized fashion? All the evidence pointed to pre-planning and collusion by agents of the government and the state. Muslims were identified through the use of voter lists, Muslim businesses were systematically torched, a Hindu woman who had married a Muslim man was killed, gas cylinders and gasoline (which are very difficult to come by in bulk quantities) were in plentiful supply, there was almost a total lack of intervention by police and firefighters.

At least 2,000 people were killed and many are missing. The survivors were sheltered in makeshift refugee camps. Even here the government was hardly visible, the camps being hastily put together by Muslim charitable organizations. The police were slow in coming to take down first information reports (FIRs), and there were no doctors on hand to examine raped women. Many local and international organizations (Citizens Initiative, Human Rights Watch) published reports in the immediate aftermath.

Massive amounts of written, oral and visual documentation have been collected and many detailed reports are available. Reports have been updated during the decade. All the evidence points to state collusion and official inaction.

The Gujarat killing is genocide because all the evidence shows that the carnage and the build-up to it were -acts "committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group" [1948 Convention on Genocide] Campaigns of hate, economic boycotts, employment boycotts, re-writing of school textbooks and demonizing of Muslims pre-dated the massacre. These activities happened at the instance of political parties (the BJP) and allied organizations – militias, youth, etc.

At SAWCC we launched "JUSTICE FOR THE VICTIMS OF THE GUJARAT GENOCIDE", (including a postcard campaign directed to Canadian prime ministers and external affairs ministers) was launched to break the silence and advocate for justice for the victims. (continued on pg. 6)

Healthy Eating / Manger santé— Stuffed Mushroom Hors d'oeuvres

Ingredients:

15 medium sized mushrooms

1/4 cup strong cheese (cheddar works well)

1/4 low fat cream cheese

2 tbs chopped walnuts

l jalapeño pepper (chopped finely) Ground black pepper to taste

Directions:

Remove the stems off each mushroom, you can use these in a stir fry or discard them. In a bowl, mix together the cheeses, nuts and pepper until smooth and creamy. Spoon filling into each mushroom top. Bake on 350F for 15-20 mins. Cool and garnish with shallots. Mushrooms provide us with good-forus selenium, they produce Vitamin D when exposed to sunlight; they're low calorie, a source of iron and they taste great!



10 years later the quest for justice is still continuing. The Chief Minister of Gujarat state at the time, Narendra Modi (of the BJP party) in a very strong campaign in which the victimized community were painted as the victimizers, utilized the genocide to win massive support in state elections which he won with a huge majority. He has denied complicity in the genocide despite testimony by credible witnesses to the contrary -- that he was directly involved in organizing the genocide as well as preventing police from intervening. Attempts by victims to get justice through the court system has faced all kinds of hurdles, from witness intimidation to biased prosecutors; mass arrests of Muslim men. In some cases the Supreme Court of India ordered trials to

be taken out of the state. Meanwhile Narendra Modi has built up very successful relationships for Gujarat with Indian (Tata, Ambani) corporate and continues to woo international business. He has become the darling of non-resident Indians, represented in Canada by organizations such as the Canadian Friends of Gujarat, Canada India Foundation and Indo-Canadian Peace Alliance. The Harper government set up a trade mission in Gujarat. Senator Di Nino and MP Patrick Brown, Chair, Canada India Interparliamentary Association visited Gujarat to attend the 4th Annual Vibrant Gujarat Global Investors Summit (2009), when they met Narendra Modi.

Some of the most tenacious legal battles for justice have been filed

and pursued by women victims of the genocide. Zaheera Sheikh, very courageously fought for justice for her family and other - 14 were burned to death in their bakery. Unfortunately she succumbed to witness intimidation and has been expelled by the Majlise-Shura, an apex decision making body of Muslims in India. Bilgis Bano whose child was bashed to death in front of her, then raped and left for dead won her legal battle. And Zakir Jaffri, the widow of a very brave individual who sacrificed himself so other could live continues, despite her age and the legal hurdles that are constantly thrown up before her, with her quest for justice. Among those named in her case are Narendra Modi.
