Prospects for the People

Since 1990, the development model pursued by India gave a sudden spurt to economic growth with GDP touching 9 percent but it also led to displacements, marginalization, environment degradation and increasing socioeconomic disparities. This period also saw increase in social conflicts and now almost one third of the country can be classified as conflict prone / disturbed area.

The present NDA (National Democratic Alliance) government led by BJP (Bharatiya Janata party) under Narendra Modi came to power in May 2014 on the plank of development for all, jobs and control over inflation- pure inclusive, economic agenda- even though BJP has a history of using blatant communal politics and a pro business approach.

The Enigmas: Can the Modi Government initiate a growth path that is inclusive and sustainable when recent history has shown that in the era of automation and computerization there seems to be an inverse relation between growth and job creation. Second, unbridled growth (as desired by the corporate bodies that heavily bankrolled the election campaign that brought Modi government to power) is possible but requires ecological degradation and displacement of countless people leading to conflicts and even armed resistance. Will increasing social unrest require the government to become more authoritarian? Finally, if the economic plank of development for all that brought the Modi Government to power fails, can BJP resort to its original tactic of communal polarisation through riots to win the general elections of 2019? What will it portent for the minorities and liberal politics in India?

A brief biography

Syed Mazher Hussain, Doctorate in Philosophy, started his career in the field of computers and education and is now involved full time in social activism since 1997. A Founder member of many organisations and institutions, Dr. Hussain started COVA (Confederation of Voluntary Associations) – a network of around 700 organisations working on issues of Communal Harmony and Community Empowerment in India and peace in South Asia. He is presently working on launching Hangout South Asia, a web based platform to facilitate interaction between the people of South Asia to promote understanding, development and peace in the region.

He has coordinated and supervised National and International Research Projects, has produced and directed two documentaries on the Freedom Movement of India and the lakes and water bodies of Hyderabad and

Dr. Hussain serves/has served on the Boards / National Committees of State Bank of Hyderabad Joint Missionary of the Planning Commission, Govt. of India, Steering Committee of the Planning Commission of India for the XII Five Year Plan, Task Force on Social Exclusion of the HRD Ministry, Government of India, , GO-NGO Coordination Committee, Government of Andhra Pradesh, VANI (Voluntary Action Network India), CNDP (Coalition for Nuclear Disarmament and Peace), PIPFPD (Pakistan India People's Forum For Peace and Democracy), Credibility Alliance, WNTA (Wada Na Todo Abhyan), South-South Solidarity amongst others.

Dr. Hussain is associated with the Refugee and Millennium Development Goals (MDGs) Programs of the United Nations and the G 20 process. He has visited over 45 countries to participate in nearly 125 international conferences and seminars.

If the economic plank of development for all that brought the Modi Government to power fails, will BJP resort to its original tactic of communal polarisation (between Hindus and Muslims/other minorities) in its efforts to win the next general elections of 2019?

#FreeJeyakumary and all those unlawfully detained

It has been over **200 days** since the arrest of Jeyakumary Balendran on 13th March, 2014. She was **detained under the Prevention of Terrorism Act** (PTA) – Provisions 6(1) and 9(1) – and sent to the Boosa detention centre the next day. To date, no charges have been filed.

Jeyakumary has been a vocal advocate and campaigned against disappearances in the North. As a direct result she has been sub-

ject to numerous threats and intimidation allegedly by State intelligence forces. Many believe she was framed by the State because she dared to challenge the authorities in her quest to find the whereabouts of her disappeared son.

The Government has accused Jeyakumary of harbouring an alleged LTTE revivalist, P. Selvanayagam a.k.a Gobi, who had forcibly entered her home on 13th March, 2014. A metal detector and a Menelab F-3 type mine detector too were allegedly recovered from within her house premises. However, despite these accusations, no charges have been filed against her in the past 6 months. Most importantly, Jeyakumary has maintained that she has had no connection, whatsoever, with this unidentified individual.

Her 13-year-old daughter, Balendran Vibushika, was unlawfully held in police custody along with her mother for 24 hours. Further, the B-Report issued by the Kilinochchi Police on the 14th of March, named Vibushika as a 'suspect' and has since been in probationary custody at a Children's Home. Probation officers took her to visit Jeyakumary once in June this year, and she has not seen her mother since.

Two Fundamental Rights petitions SCFR/126/14 and SCFR/127/14 – were filed in the Supreme Court on behalf of Jeyakumary and her daughter on 12th May, 2014. Their cases have been heard six times since May. At the last hearing on 16th September, 2014 the Attorney General Department stated that the Police required more time and that investigations are ongoing. The next hearing will be on 17th December, 2014.

Jeyakumary is not the only victim of unlawful detention. Between January and April of this year alone, over 80 people were arrested and unlawfully detained by the Terrorist Investigation Department (TID) in a mass scale round-up in the North and East. At least ten women and children were among those arrested.

Jeyakumary is a widow from Kilinochchi. Her eldest son, Balendran Yohan worked as a labourer. He was shot and killed at the age of 20 in 2006, allegedly by a para-military group supporting the Government forces. However, no one has been arrested for his killing to date. Her second son, Balendran Kajeevan too, was also killed in a shell attack while en route to the government-controlled area in May 2009.

Jeyakumary last saw her youngest son, Balendran Mahinthan in 2008, when he was forcibly recruited by the LTTE, at the age of 15. He survived the war and was last seen surrendering to the Sri Lanka Army (SLA) at Mullivaik-kal, in May 2009. Further, she recognized him in a photograph, undergoing rehabilitation with other child soldiers at a State-run rehabilitation centre, originally published on lankapuvath.lk, a State-owned online news site, after the end of the war.

She then filed a complaint with the National Human Rights Commission (NHRC), Jaffna (Reference No. HRC/152/2014) on 8th January, 2014, on his disappearance. Consequent to this complaint, the NHRC was informed by the Commissioner of Prisons, that Balendran Mahinthan was not in the custody of the Department of Prisons.

The Commissioner General of Rehabilitation too informed the NHRC that Balendran Mahinthan had not been included in any rehabilitation process, even though there is photographic evidence of him undergoing rehabilitation at a State-run Centre.

Jeyakumary has been forced into prolonged detention with no conclusive evidence to charge her for the accusations under which she was arrested. Investigations have progressed in a lackluster manner. 200 days into her arrest, State Authorities are yet to produce substantiated evidence to justify her arrest and detention.
